SALE/ADOPTION CONTRACT

General: The following agreement is between "Seller", Marcella Zobel, Golightly Borzoi (& co-breeder, if any) and the buyer(s) ___{your name here} __, hereafter referred to as Buyer(s), for the purchase of one purebred Borzoi named: _Golightly _____)

With a microchip #_____

Description: male/female borzoi, white trim, brindle points.

Date of Birth: October 31st, 2006

AKC Registration Number: HP_____

In consideration of the price of _\$1,000.00_. (payable in installments) The sellers transfer all rights, privileges, and responsibilities associated with the ownership of this Borzoi to Purchaser subject to the conditions set forth below as of the date specified. This represents the entire agreement between Sellers and Purchaser in an outright sale.

Use of the Borzoi being purchased: It is agreed between Sellers and Purchaser that this dog is being acquired mainly as a family companion and that it can be used for tasks appropriate to its breed, such as lure coursing, hobby racing, therapy dog, or for exhibition in shows, obedience or agility competition as Purchaser may desire. We agree that this puppy is not purchased for resale to another person, and all parties agree this Borzoi can be returned to Sellers or co-breeder(s) if for any reason Purchaser needs to re-home this Borzoi at ANY POINT in it's life.

Golightly Borzoi encourages the Buyer(s) to train the puppy & recommend the following classes:

Puppy Kindergarten;

Canine Good Citizen Tests, conformation classes

Obedience & Agility classes; & lure coursing.

Health: The Seller(s) warrant that the puppy is in good health and free from parasites (fleas, ticks, worms, etc.) as of the time of sale. The health record of the dog is included in the sale. As part of this contract Seller(s) require the Buyer to have the dog seen by a Veterinarian of Buyer's choice within 10 days of picking up the dog and to follow the

veterinarian's directions for the future care of the dog. If at any time during the life of the dog it develops health problems which in the opinion of two licensed veterinarians are likely to be of an inherited nature, which are unexpected in a dog of that age, and which will interfere with the dog's function as a pet, Buyer agrees to contact the breeder/Seller(s). Buyer may return dog (as below) or keep the dog and Seller will rebate 20% of purchase price.

Right of Return: Said dog may be returned to Seller(s) for any reason at any time following purchase. If returned within two months from purchase and provided that the dog has not been injured or damaged in any way, the Buyer will then be entitled to a refund of the original purchase price. Refund amount will be reduced by 10% of purchase price for each additional month that the dog is kept. If on return to Seller(s) the dog requires veterinary care or incurs other expenses due to negligence on the part of the Buyer, such expenses will be deducted from the refund amount. However, regardless of the provisions above, if the dog is voluntarily returned to Seller at any time in its life, with its signed papers, Buyer is entitled to a refund of 20 percent of the purchase price.

Right of Recovery/Placement: In the event that the Buyer is unable to keep the dog or provide an appropriate home in accordance with this agreement, Buyer(s) agree to contact Sellers. Buyers may return the dog to Breeder, or with the Seller's assistance, place the dog in a home of mutual choosing (approved by the Buyer & Sellers). Buyer will not abandon the dog, surrender it to a shelter, or without the seller's written permission, sell or give the dog away. If dog is found to have been sold or given away without the seller's permission, Seller(s) may take legal action to recover the Borzoi and original Buyer of the dog will be responsible for all expenses incurred in getting the dog back.

Registration: This Borzoi is able to be registered with the American Kennel Club as a purebred Borzoi. If purchased as a Pet/Companion/Non-Show dog we will provide forms for transfer of such registration upon spaying/neutering of this Borzoi. Until spayed, co-ownership papers can be provided to Buyer(s) if they so wish.

Ownership responsibilities: The Buyer agrees to maintain the dog as a house dog in a humane environment and properly socialize, train, and care for it. The dog will be properly licensed, will be kept substantially free from parasites, and inoculated against rabies, distemper, parvovirus and other communicable diseases, and will be maintained on heartworm preventative medication as recommended by a qualified veterinarian. Purchaser understands that as a matter of breed characteristics, Borzoi are likely to kill small mammals and accepts all responsibility for any such event. Purchaser also understands that Borzoi are likely to run away and must at all times be confined to a fenced area or restrained by a leash except in safe dog areas, and upon training in a good recall. (Borzoi are able to learn to come when called). The dog will not be allowed to roam at large unsupervised.

Spay/Neuter: If this dog is being sold as a pet, not a breeding animal, the Buyer agrees not to breed the dog and to have the dog spayed or neutered when the pup is about a year old. Health benefits of spaying are greatly increased if the surgery is performed before the dog's first estrus, generally occurring between 9 months and 18 months of age, but Buyer should follow the recommendations of a veterinarian.

All parties agree to maintain contact with each other and provide each other with any change of address or phone numbers within 30 days of such change. Christmas Cards will be nice to exchange, too!

Limit of refunds and rebates: In no case will the total amount returned to the Purchaser exceed the amount paid by the Purchaser to the breeder/seller.

Jurisdiction: Buyer agrees that this contract will be bound by the laws of the State of California and that any dispute regarding this contract will be settled in a California State court in the County of Monterey.
